

Kittens Unlimited Adoption Agreement

AGREEMENT dated _____ between Kittens Unlimited (hereinafter “KU”) and _____ (hereinafter “Adopter”).

Whereas Adopter wishes to adopt certain Kittens Unlimited owned animal described as _____ (hereinafter “Animal”), the following terms and conditions shall apply:

1. Adopter agrees to comply with all relevant municipal, county and state laws and ordinances related to the keeping of this Animal, including, but not restricted to, rabies vaccination. Adopter will not allow Animal to run free and will ensure that he/she will not become a nuisance or menace to other people or their property.
2. Adopter accepts the responsibility for humanely caring and providing for this Animal’s welfare and agrees the Animal will always receive quality food, water, shelter, companionship, safety and veterinary care as needed and all vaccinations will be kept up-to-date.
3. Adopter agrees that Animal will be kept strictly indoors.
4. As the Adopter, I agree to return this Animal to KU if I no longer want or am unable to keep him/her. I will not sell, trade, give away or dispose of the Animal in any way. I further understand that this Animal shall not be surrendered to any organization except KU, shall not be used for medical or experimental purposes, shall not be used in any aspect of dog/animal fighting, shall not be abused, neglected, or abandoned. _____ (Adopter Initials)
5. Adopter agrees to pay KU the required adoption fee. KU will give a full refund of the adoption fee up to fourteen (14) days from the date of adoption. After that time, no refund will be given.
6. It is expressly understood by and between the parties that KU may have little or no information or records pertaining to the Animal’s history. Adopter understands that KU is a rescue organization and may be able to provide only current medical records. Adopter expressly understands that the animal is adopted AS IS.
7. Adopter agrees that KU has made every effort to provide for and protect this Animal’s health during the time he/she has been available for adoption. Adopter understands that KU is not responsible for any physical condition or medical fees incurred after the adoption date. However, if a health emergency develops during the first ten (10) days, Adopter is to contact **Pam Iversen** at **(614) 403-4088**.

8. Adopter covenants and agrees that KU or any authorized individual acting on its behalf may examine or make inquiry about the Animal at any time, with or without notice to Adopter. If said examination or inquiry demonstrates that the animal is not being cared for in a manner wholly consistent with the above representations and/or representations made by Adopter on the adoption application, Adopter agrees that KU, or any authorized individual acting on its behalf, may reclaim the Animal and place it back up for adoption without payment or compensation to Adopter. Adopter hereby expressly authorizes and licenses KU or any authorized individual acting on its behalf to enter onto the Adopter's property for purpose of making inquiry or examining the Animal and/or for the purpose of reclaiming such Animal. Adopter waives any claims for trespass or damage that they might otherwise have arising out of said reclaiming.
9. Release of liability: Adopter hereby agrees to take possession of this Animal with the full understanding that such Animal, by his/her very nature, can be aggressive and that such aggression may cause injury or death to Adopter and/or others. In redeeming said Animal, Adopter accepts full and complete responsibility and liability for the actions of this Animal in causing injury or death to self and/or others. Adopter understands that KU makes no representations or guarantees as to the temperament, health or mental disposition of any animal available for adoption. Adopter further agrees to indemnify and hold harmless KU, its agents, volunteers and/or board members for any such personal injury/death/damage caused by such Animal now or in the future.
